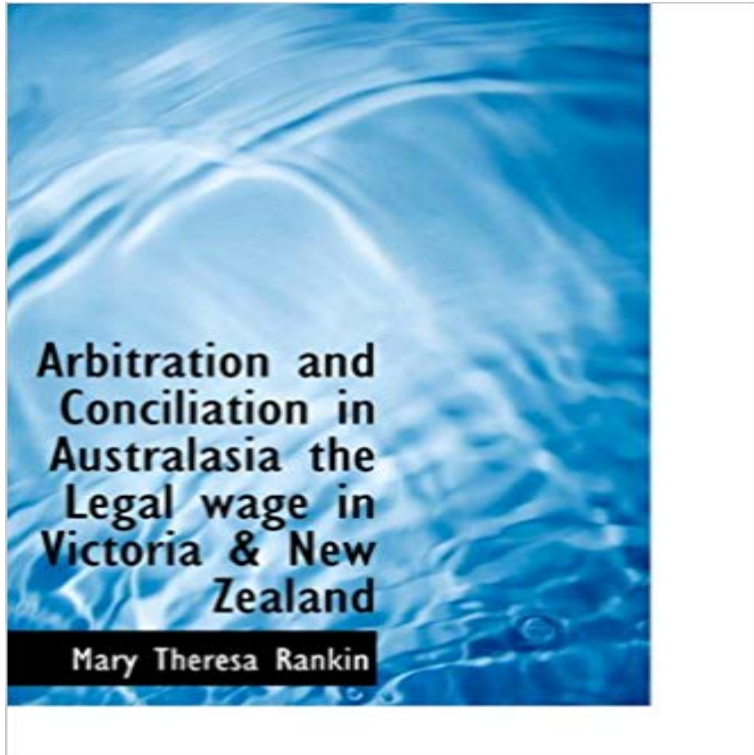


# Arbitration and Conciliation in Australasia the Legal wage in Victoria & New Zealand
