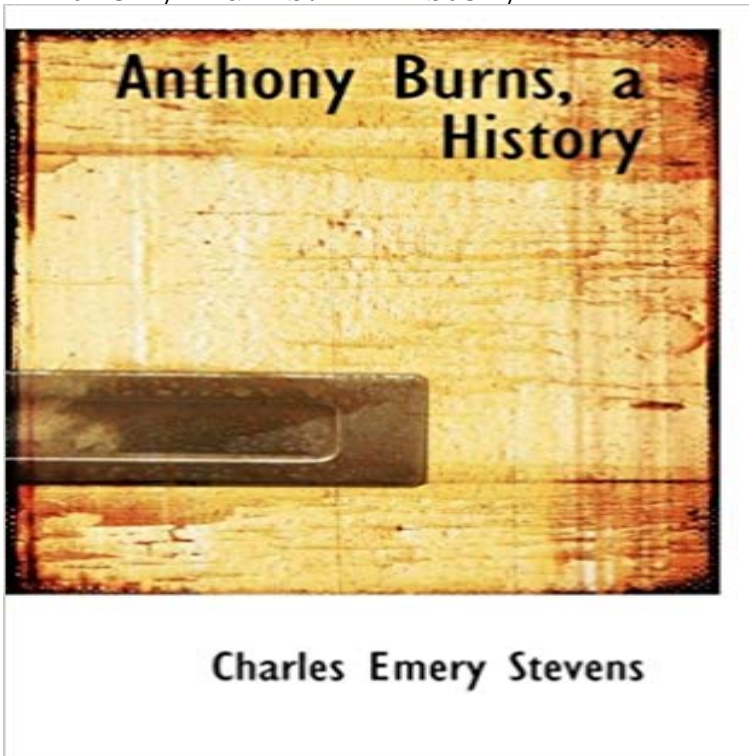


## Anthony Burns: A History
